**The purpose of personal data processing, for which the personal data are collected to the extent of name, surname, date of birth, permanent residence, email address, phone number, ID card (passport) data** is the provision of controller's accommodation services – contractual and pre-contractual relations.

**The legal basis of personal data processing is** the contractual or pre-contractual relationship between the customer and the controller.

**Identification of the recipient or recipient category, if any (third parties, intermediaries):** provision of personal data of aliens to the Aliens Police.

**Personal data retention period or information about criteria for determination thereof:**  
from acquisition for the period necessary to achieve the purpose of processing.

**The provision of personal data by the data subject is the requirement necessary for entering into a contract. If the data subject refuses to provide the data, it shall not be possible to fulfill the purpose of processing.**

### **Rights of the data subject:**

right to access the personal data,  
right to rectification of personal data,  
right to erasure of personal data ("the right to be forgotten"),  
right to limitation of personal data processing,  
right to object to personal data processing,  
right to portability of personal data,  
right to withdraw his/her consent to personal data processing at any time,  
right to file a complaint to supervisory authority

**The purpose of personal data processing, for which the personal data (to the extent of capturing individual characteristics and data about the concerned natural person, information relating to physical, psychic, economic, social or cultural identity) are intended** is to protect public order and safety, to uncover crime, violations of nation security, and to protect property and health.

**Legal basis of personal data processing:** legislation

**Identification of the recipient or recipient category, if any (third parties, intermediaries):** court and law enforcement bodies.

**Personal data retention period or information about criteria for determination thereof:** from acquisition for the period necessary to achieve the purpose of processing, maximum 14 days.

**Information on whether the provision of personal data is a legal requirement or a contractual requirement or a requirement necessary for entering into a contract and on whether a data subject is required to provide the personal data, as well as the possible consequences of not providing the personal data:** provision of personal data by a data subject is a legal requirement; if the data subject refuses to provide the data, it shall not be possible to fulfill the purpose.
